Other changes. The Interim Conference was renamed the Interim Meeting and became a weekend, no frills event. The agenda concentrated on in-house affairs. Then came Covid-19. While it cancelled the 2020 Interim and the 2021 Conference, it opened new possibilities and new connections through virtual meetings.

The 75th Anniversary Book of 2006 was a hardcover publication with 244 pages of history plus essays and photographs in black and white and color. The 2011 edition, 83 pages, completed the decade called The New Century. We have titled this new decade, beginning in 2016, Rebranding for the Future.

Rebranding for the Future

This five-year time frame promoted the image of a contemporary organization aligning its brand with its current goals and addressing a younger and more international club membership.

A logo was commissioned to embody these concepts. It symbolizes a transition from an American focus to a global attitude, with red, white and blue colors on the left sweeping into global colors on the right. It presents a welcoming and open-minded community of international women — dynamic, inspiring, positive and engaged — who embrace everyone with shared values.

The logo says that FAWCO is multi-dimensional and outward looking, taking its place on the world stage. A new Mission Statement and a tagline, Inspiring Women Worldwide, were introduced to further this brand.

The Red Book History

Interim Meeting Frankfurt 2016

This first Interim Meeting (IM) to be scaled down to a two-day weekend event was held near Frankfurt, Germany, March 11-13. It offered a no-frills meeting at a reasonable price. There were 119 delegates from 34 clubs.

The theme was Celebrating 85 Years of FAWCO. Rick Chimazdia, FAUSA Vice President of Communications, entertained with a visual history presentation at the opening dinner. A five-year update of the FAWCO history, *The Red Book*, was published by co-editors Georgia Regnault (AWC The Hague), and Nancy Thornley (AWA Rome/FAUSA), and distributed to the participants.

The Rebranding Task Force, appointed by President Monica Jubayli (AWC Lebanon) in Rome, took a fresh look at promoting an image of a contemporary organization with a younger and more international club membership. Chair Kathleen Simon (AWC Bern) worked with Accent Brand Consultants Ltd. of Zurich. It designed a logo to denote a transition from an American focus to a global attitude – red/white/blue colors on the left sweeping into global colors on the right. Multi-dimensional and outward looking, the new FAWCO brand shows an organization taking its place on the global stage. A new mission statement was proposed as well as a new tagline – Inspiring Women Worldwide. These changes were approved by the membership.

Elizabeth Abbot (AILO Florence) was appointed chair of a new Financial Future Task Force to help lead FAWCO into the future by addressing budgeting, identifying potential companies and foundations, maximizing internal resources, and creating promotional materials.

The three-year Target Program on Human Rights for Women, Free the Girls, ended. \$172,000 was raised for this cause. The theme for the next Target Program was announced: Education – Empowering Women Through Knowledge and Skills.

Dublin hosted the FAWCO Youth Program, June 7-12, with five teens from Germany, two from Italy, and two from Dublin.

At the request of FAUSA, the Disaster Relief Fund was activated for the earthquake in Nepal. FAWCO raised \$11,748 to help build houses and assist The Asian Resource Foundation.

“How-To” sessions included how to log onto the website; make the most of club workshops; build the ideal FAWCO budget; craft a successful education award or development grant application; make the best of FAWCO publications; increase membership; and host a regional meeting.

The Interim Meeting provided enough time to celebrate FAWCO’s 85th Anniversary, to review the accomplishments of the past year, and to provide for FAWCO’s future.

XXXXIII Biennial Conference Mumbai 2017

This was the second Conference, and first Biennial, to be held in Region 11. With a theme of *The Butterfly Warrior – Learn – Reach – Shine*, 100 delegates from 28 clubs, representing all 11 regions, gathered from March 30 - April 2 at the Hotel Trident Nariman Point. A pre-Conference newsletter was created, *Spotlight on Mumbai*, which featured such topics as travel, hotel, health, food and local etiquette. Also included was FAWCO content - speakers, workshops, Resolutions and Recommendations and Nominations.

Distinguished speakers talked of the progress and challenges facing the women of India as well as their untapped economic potential.

The FAWCO Foundation celebrated its 50th Anniversary. It was incorporated on February 26, 1967, by its founder and first president, Mary Mag-Hasse of Rome. The first contribution was \$200. To mark this event The Foundation adopted a new logo designed by Accent Brand Consultants; it incorporated the new FAWCO symbol yet emphasized a separate Foundation identity. The Foundation announced a new mission statement: "The FAWCO Foundation supports the philanthropic goals of FAWCO by developing, administering and fundraising for programs that improve the lives of women and children worldwide." The Foundation night gala was *A Heart of Gold*.

President Monica Jubayli reported on Regional Meetings in Berlin, Casablanca and London. She was also able to meet with clubs in Singapore, Barcelona, as well as Qatar before AWA Qatar had to resign for political reasons. The board met on Skype and GoToMeeting; face-to-face meetings were considered the more productive.

On January 23, 2017, the Rebranding Committee applied to the US Patent Office to register the new logo.

The new Target Project was announced: Hope Beyond Displacement. An initiative of the Collateral Repair Project in Amman, Jordan, it aimed to build better futures for Syrian refugee women and girls through education, vocational and leadership training.

The UN team reported on its activities that support the UN Sustainable Development Goals. A new online quarterly, the *Inspiring Women Magazine*, was introduced. It presents accomplished FAWCO members who excel in various fields. The Caroline Curtis Brown Spirit Award was given to Elsie Bose, Mary Adams and Johanna Dishongh.

Johanna Dishongh and Mary Adams organized a two-day Symposium on Human Trafficking, October 8 - 9, 2016, in The Hague. Sponsored by both FAWCO and The Foundation, the Symposium was attended by 70 FAWCO members from 9 regions as well as 13 members of the general public. There were 16 speakers and 8 participating NGO organizations that are involved in helping trafficking survivors become self-sufficient. \$8,869 was raised and given to these organizations. In addition, a pre-symposium experience was offered to FAWCO members in order to provide a deeper understanding of the survivors and their journey from rescue to empowerment.

The new board was elected: President Sallie Chaballier (AAWE Paris); Secretary Mary Stewart Burgher (AWC Denmark); 1st VP Laurie Brooks (AWC The Hague); 2nd VP Hope Moore (IWC Munich); 3rd VP Martha Canning (AWC Amsterdam); Treasurer Alisa Cook-Roehs (AIWC Düsseldorf).

The legacy of the 2015-2017 Board, beginning with the re-branding of the FAWCO image, continued into the next term - a new look, a refreshed Mission Statement, a joint FAWCO/Foundation event, and a strategic plan to give direction to the future.

Interim Meeting The Hague 2018

This was the second FAWCO weekend Interim Meeting . It was hosted at the Marriott Hotel March 23 – 25 with 144 delegates from 39 clubs in 21 countries, plus FAUSA; there were 34 first-time attendees. Although there was no host club, pre-and-post conference tours were planned by the AWC of The Hague. With a full agenda, the meeting began on Friday afternoon.

President Sallie Chaballier created a new Advancement Committee to explore ways to expand and diversify both revenue streams and possible grants. This committee, along with the Finance Committee and the Strategic Planning Task Force, stressed the importance of a dues increase. The membership approved an increase of 10% to take effect in 2019.

The Strategic Planning Task Force also recommended accountability and compliance with the Resolutions and Recommendations approved for 2017-2019. Their report included recommendations centered on organization, communication, membership and finance.

The Saturday morning session opened by adopting a UN Resolution supporting the March for Our Lives taking place that day in the United States. The Executive Director of the Collateral Repair Project, our Target Project in Amman, Jordan, presented two workshops.

Other workshops were on both club issues and global Issues. Club issues concerned financial health, publications, the modern family, fundraising, tax reform and estate planning. Global issues focused on refugees, such as “Networking to Support Refugees: FAWCO Clubs Creating Connections Across Borders.” This workshop inspired the creation of a new FAWCO committee that wished to build on and exchange ideas.

The United States Patent and Trademark Office approved registration of the new FAWCO logo in August 2017. It is valid for 10 years, then needs to be renewed.

Emily van Eerten received the Caroline Curtis Brown Spirit Award for her work on the transition of the Archives to the Expat Archive Centre in The Hague and her development in the 1990s of the early FAWCO website.

This Interim Meeting was successful in its concept, that of a short and intense time frame, using FAWCO presenters, in order to concentrate on FAWCO’s work and its members’ concerns, to be both local and global.

XXXXIV Biennial Conference Edinburgh 2019

This first-ever Conference in Scotland was hosted by AWC Central Scotland, Edinburgh, Glasgow and St. Andrews, March 21 - 24 at the Dalmahoy Hotel and Country Club. This venue began life in 1725 as a baronial manor house once visited by Mary Queen of Scots; many renovations later, it is a golf resort set on 1,000 acres of parkland.

The theme was Bonnie Brave and Beneficent. Of the delegates, 138 from 11 regions were full-time; in all, 254 people made up the company of delegates, guests, speakers and volunteers. Each day was devoted to a global issue category – Education, Health, the Environment, and Human Rights.

President Sallie Chaballier announced that financial management and planning had been a priority of her board and was pleased to report that, with careful budgeting, the accounts were in good order. The Administrative Guidelines have been updated. An Events Planning Handbook for both Interim Meetings and Conferences have been published. The president attended meetings in Bern, Barcelona, Heidelberg (the newest club), Marrakesh, Rome and Beirut.

The board created a new committee, Public Relations and Media, to expand and professionalize FAWCO's external communications and to boost its public profile. Meenakshi Advani (ACIW Mumbai) is the chair.

FAWCO became a member of the Board of the Conference of NGOs in Consultative Relationship with the UN (CoNGO). This board often approves signing statements and position papers in conjunction with other NGOs. Johanna Dishongh (FAUSA) replaced the late Lucy Laederich as US Liaison. Johanna and US Tax & Banking Chair Cora Lee Findley (FAUSA) attended Overseas Americans Week in Washington DC in April 2018. The Voting from Overseas Committee assisted in registering members to vote.

In its fifth year, FAWCO Youth's Cultural Volunteers program hosted twelve teens from eight FAWCO clubs in Berlin June 23 - 30, 2018. They represented eleven cultures speaking nine languages. They volunteered with the homeless and disabled as well as absorbing the German culture with walking tours and museum visits. A highlight was meeting with Margot Friedlander, a Holocaust survivor who read from her book, *Try To Make Your Life*.

The Target Project, Hope Beyond Displacement, had been a large success under the direction of Tricia Restivo Saur (AIWC Cologne), Chair of the Target Program for Education. Publications, social media, film, a FAWCO-wide action campaign to heighten awareness – all helped to raise \$125,000 in the first year. A new fundraising goal was set. With additional money totaling \$190,000, over 1200 more refugees were provided with educational tools, supplies, vocational skills, and awareness training on gender-based violence and empowerment. The success was augmented by several factors. Amanda Lane, the director of the Collateral Repair Project (CRP), personally visited FAWCO clubs in Germany and The Hague, as did Therese Hartwell (AW Eastern Province). Therese was a member of the FAWCO Human Rights Team as well as a CRP board member. In addition, 22 women, including FAWCO, Foundation and FAUSA board members, made a three-day site visit to the program in Jordan.

The Foundation Night Gala, *Be True to Your School*, raised \$30,000 for the Foundation's Education Awards and Development Grants.

A moving tribute to Lucy Laederich was presented in words and film. A fund in her name was created.

Kristin Haanæs (AWC Oslo) was awarded the Caroline Curtis Brown Spirit Award.

The FAWCO Bylaws were modified to permit up to two non-US citizens to be elected to Board positions other than President, in recognition of FAWCO's international clubs and a sign of respect to our non-US volunteers. A second amendment to the Bylaws changed the beginning of FAWCO's fiscal year to coincide with the start of the calendar year.

The new board was elected: President Emily van Eerten (AWC The Hague); First Vice President Ann Marie Morrow (AWC Finland); Second Vice President Rozanne Van Rie (AWC Antwerp); Third Vice President Mary Dobrian (AIWC Cologne); Secretary Amanda Drollinger (AWC Central Scotland); Treasurer Alisa Cook-Roehs (AIWC Düsseldorf).

This two-year term concentrated on fulfilling the 2017-2019 Resolutions and Recommendations to strengthen support for member clubs, to expand the links between clubs and Global and UN issues, and to continue advocacy for women and girls worldwide.

Interim Meeting Luxembourg 2020 — Cancelled

Planned for March 20 – 22 at the Parc Alvisse Hotel, this in-person meeting was abruptly cancelled on March 12th due to worldwide travel restrictions as a result of the Covid-19 virus.

Three issues of a pre-conference magazine, *Spotlight on Luxembourg*, had prepared the delegates for an inspiring weekend. Conference events were rescheduled and adapted for the virtual Zoom platform on Saturday, March 21st. These sessions included the reports on UN Advocacy, US Voting, FAWCO Youth Team, Clubs in Motion and Using Social Media. FAWCO Counselor Celeste Brown hosted a virtual Laughter Yoga class. The meeting was recorded.

President Emily van Eerten attended Regional Meetings in London, Amsterdam, Leipzig, Casablanca, and Madrid in 2019. She welcomed a new club, the American International Women's Association of Venice.

Internal technical improvements for the year were made to the online website database, and to the conference registration procedures. An Administrative Resources Shared Drive was established as a centralized and permanent home for such organizational documents as Bylaws, AGs, R&Rs, position papers, current club information and logo master files. FAWCO embraced the tools of G Suite including using Google Meet for board and other online meetings. As the General Data Privacy Regulation (GDPR) took effect in 2018, the board directed attention to compliance and improvement of our data privacy protocols.

Two Task Forces were created. The Under 40 Task Force, chaired by Christine Funke (Heidelberg IWC), was asked to identify the needs of the younger members; and a regular

virtual Happy Hour was initiated. The Brand Strategy Task Force, led by Melanie Baur (AWC Berlin), recommended strategies to improve FAWCO's social media presence as well as consistent branding on documents, slideshows and the FAWCO website. FAWCO Counselors Sallie Chaballier (AAWE Paris) as Web Content Manager, and Monica Jubayli (AWC Lebanon) as Documents Manager, serve as proofreaders and quality control for FAWCO branded content.

The Lucy Stensland Laederich (1944-2019) Memorial Fund raised \$4000. A portion was sent in her name to the Turning Point Suffragist Memorial in Washington DC with the remainder earmarked for US Issue-related activities. FAWCO has also made a separate donation to Turning Point.

S.A.F.E., Safe Alternatives for FGM Elimination was selected as the fourth Target Project under the Target Program Health theme, *Promoting Well-Being and Healthy Living for Women and Girls*.

The Foundation raised over \$20,000 at a three-hour Live-on-Zoom auction.

FAWCO Rep Appreciation Awards were given to Christine Riney (AWC Hamburg); Magda Honffy (AWC Antwerp); Georgia Kallis (AWO Greece); and Julie Mowat (AWC The Hague).

Virtual Open Regional – November 2020

2020 will go down in history as an extraordinary year. It was no different for FAWCO. As the March 2020 Interim Meeting was cancelled, the board optimistically planned an in-person Open Regional meeting for November, to be held in Luxembourg. In the end, this too had to become an online meeting and the board worked diligently to find another interactive platform which would better emulate a conference experience than Zoom or Google Meet. It finally chose the Hopin platform, which gave the registrants the opportunity to move between Stages, Sessions, one-on-one Networking and Expo Booths. Live programming over the 72-hour event was similar to an in-person conference, but the event space remained open between the live events allowing participants to explore recorded content in the Expo Booths and interact with each other through the chat and session functions. Except for a few glitches, this first experiment in interactive online video conferencing was considered a success.

As Covid-19 restrictions continued, planning for the XXXXV Conference, which was to have been hosted by FAUSA in the USA, also had to be abandoned. The Biennial Conference will instead again be hosted on the virtual Hopin platform March 18-21, 2021.
